The 1995 low vision literature: a bibliography

In this issue of the *Vision Impairment Research*, we continue the tradition of including a comprehensive, current bibliography of the low vision literature. This issue focuses on the year 1995. The bibliography is based upon *Low Vision - The Reference* edited by myself and Dr. Randall T. Jose, a bibliographic reference containing in excess of 6,400 citations. The 3rd edition of this reference has recently been published by The Lighthouse Inc., New York and is available in print or computer formats. The printed version contains an alphabetical author index and an 81-term keyword index. The keyword index is organized in reverse chronological order to aid in looking up the most recent articles by topic. The computer formats are now available in versions compatible with EndNote for either Macintosh or Windows operating systems. The EndNote versions contain an EndNote browser which allows for searches by author, year, word(s) in title, journal, or keyword or any combination of up to three of these fields.
